新型コロナウイルス感染症の感染拡大に対する警戒強化について

昨年末からの全国規模でのコロナウイルス感染者の増加による 1 月 7 日付緊急事態宣言を受けて、本学園(小・中・高等学校)共通の対応規準を再徹底する。

① 外部からの来校者への対応

来校者について、マスク着用と消毒のほか校舎内に立ち入る場合は検温を求めることを継続。(見学者、設備修繕や管理のために校舎に立入る業者の方)

学校事務窓口にて業務が完了する場合は検温を求めない。(郵便局員、運送会社、教材販売業者の方等)

保護者の方については、児童・生徒同様に自宅での検温をお願いします。

② 行事への参加

都市部(緊急事態宣言が発令された都道府県)からの来校者は 2 週間前からの検温データ(自主申告としますが、申告書を徴求)により参加の可否を判定する。(厚生労働省の目安 息苦しさや強いだるさ、高熱など強い症状は PCR 検査を受けるべきか否か相談、比較的軽いかぜの症状が 4 日以上続く場合は必ず PCR 検査の受診相談を行うこと。)

③ 教職員の移動についての対応

都市部 (1月7日現在で緊急事態宣言が発令されている都道府県) への訪問を行った場合、福山に帰省後2週間の自宅滞在を求める。(自宅にて2週間の健康観察を行い、異常が見られない場合、またはPCR検査を受診して陰性の場合、職場復帰ができるものとする。) 移動先の都道府県が発信する情報を確認し、リスクが高いと思われる地域への移動や施設利用を控えることとする。

④ 研修・出張についての対応

今年度必修となる研修を除き、都市部への出張、研修は認めない。 必要上、参加した場合、上記のとおり研修後2週間の自宅待機を求める。

⑤ 飲食店の利用について

広島県の「新型コロナウイルス感染防止対策取組宣言店」ほか、ガイドラインに基づいた感 染防止対策を講じている店を利用すること。

⑥ 濃厚接触者となった場合又は濃厚接触者とされた人との接触が判明した場合、すみやかに学校管理職または健康管理センターに報告すること。

About strengthening vigilance against the spread of new coronavirus infection

Following the declaration of a state of emergency on January 7, 2021 due to the increase in the number of coronavirus cases nationwide since the end of last year, the school (elementary, junior high, and senior high schools) will re-emphasize the common standards of response.

① Response to visitors from outside

In addition to wearing a mask and disinfecting, visitors are required to take their temperature when entering the school building. This includes people who enter the school building for equipment repairs and management. Visitors such as post office staff, shipping companies, teaching material distributors whose business can be dealt with at the window, such as post office staff, do not need to take their temperature. Parents, on the other hand, need to take their temperature at home just like the students.

2 Participation in the event

Visitors from urban areas such as prefectures where a state of emergency has been declared will be evaluated as to whether they can or cannot participate in the event based on their temperature readings two weeks before the event. This is voluntary, but a declaration is required.

The Ministry of Health, Labor, and Welfare released the following signs of Corona Virus Infection; (1) breathlessness (2). fatigue, (3). high fever

Anyone who experiences the symptoms above or a relatively mild cold symptom for more than four days should get a PCR test.

③ Responses regarding teachers and staff travel

Teachers and staff who visit urban areas such as prefectures where a state of emergency has been declared as of January 7th 2021 will need to stay at home for 2 weeks. They need to observe their health condition for two weeks at home and if there are no health issues observed or they receive negative PCR tests, they can return to work.

The school advises teachers and staff who plan to travel to check the situation and information of the prefecture of their destination. The school advises teachers and staff to refrain from going to places with high rate of Corona Virus infection.

① Training and business trip support

Except for some mandatory training this year, business trips and training held in urban areas are not allowed. Any teachers or staff who participate in training in urban areas will be asked to stay at home for two weeks after the training and follow the procedure described above.

(5) About the use of restaurants

Teachers and staff are advised to only go to stores that implement infection prevention measures following the "New Coronavirus Infection Prevention Measures Declaration Store" in Hiroshima Prefecture.

⑥ Teachers and staff who had close contacts with a person infected by COVID-19 should promptly report to school management and health care center's teacher.
